Council Members:

As a 37-year resident and homeowner in Torrance, located under the west departure path

of Torrance Municipal Airport - Zamperini Field (KTOA), I urge you to please NOT implement

landing fees.

A "NO" vote preserves the balance of public, personal and business interests.

KTOA serves the general public as a vital transportation link to the national airspace system.

KTOA serves individuals engaging in education via flight training, recreation and pleasure flying.

KTOA serves business interests and the local economy, providing revenue to the city coffers,

local businesses such as flight schools, hotels, restaurants, car rentals and retail shopping.

These businesses provide jobs and revenue. Why would you want to put in place an additional burden that discourages all these positive things from continuing to flourish in our city?

This is akin to having a fee to enter your driveway from a city street.

What have the aviation community, airport management and the city done to mitigate noise

exposure to the community that has developed around an active airport? In fact, plenty of actions

have been implemented. To name several: departure curfews, training restrictions, banned

aircraft types, noise limits with active monitoring, noise abatement procedures subject to safety

within FAA rules and regulations, noise abatement signage at runways for pilot reference,

and over time, increased use of newer and quieter aircraft. The Torrance Airport Association has communicated noise reduction tips to its pilot members, as has the Aircraft Owners and Pilots Association in communicating noise awareness steps for pilots to use in flying over noise-

sensitive areas.

More needs to be done to get the word out to pilots that visit KTOA from other cities and states.

Torrance needs to submit the noise-sensitive information to the FAA for inclusion in the official

publication called Digital Chart Supplement (aka Airport/Facility Directory) that pilots use to

familiarize themselves with intended destination airports. Past KTOA noise data reveals upwards

of 2/3rds of noise monitor violations were attributed to transient flights, not KTOA-based pilots

and planes. Also, about 17% of noise "violations" were from emergency/fire/police/military

flight operations. I doubt the good citizens of Torrance want to curtail those vital services.

Looking at the July data on the Torrance Airport Noise Lab website, the vast majority of

noise complaints are from the west end departure path, which is mostly around Hawthorne

Blvd., businesses and some homes, but not the south hillside residents that were previously

vocal about alleged noise violations. Could it be those measures taken voluntarily by pilots and

flight schools are taking effect? Perhaps you should allow some time to watch this trend, before

acting on the proposal.

Do not take measures that hinder the proper use of Torrance Airport. Look no further than

Santa Monica Airport's impending demise from such measures. Think of the increased air traffic

that LAX will be allowed to route over that city with the removal of their air space from the map.

The same might happen over Torrance, should you initiate the demise of KTOA. I'd rather listen to

a few small aircraft occasionally flying over than a constant flow of airliners.

I am a Hermosa Beach resident who lives in multi-unit housing.

It would help the entire Southland if we can have smoke-free housing. Torrance can be a leader on this extremely important public health standard.

We own a condo with a fantastic view of the ocean. But I have to sleep with my ocean-view door closed because I have neighbors who smoke pot on their balconies. It's unfair I have to box myself in, especially as the weather is getting warmer.

My son has a room in a different part of the condo. His windows are also closed. A couple of nights ago, he came into my room at 3am, complaining that pot smoke was coming through the walls/vents and it woke him up.

This is not just bothersome, it's serious. My son has allergies.   - a. 2x as much tar and ammonia as tobacco smoke
    b. 8x as much hydrogen cyanide as tobacco smoke (9)
    - Tetrahydrocannabinol (THC), the active chemical in cannabis that leads to secondhand high (10)
